# Know the risks with portable generators

CLAVERACK REC has excellent experience in reliability. However, Mother Nature sometimes shows her power and is the No. 1 cause of major outages for all electric providers.

While we work hard to provide reliable service, there will always be occasional power outages. When outages do occur, some members turn to portable generators to meet their electricity needs.

It's important for anyone who uses or is considering purchasing a generator to be aware of the serious potential hazards involved in using portable generators.

If connected and used properly, they can be a blessing during a prolonged outage. But improperly installed or operated generators can have deadly consequences.

If you are thinking of using a portable generator, please take a moment to review some of the basic facts and risks associated with generators:

- ► Know the capability of your generator, the size and what load it can actually power in your house.
- ▶ Never set up a generator indoors or in garages. Using a generator inside of a building is one of the top causes of carbon monoxide fatalities.
- Make sure your generator is turned off and cool before you refuel the engine to prevent the potential of

fire while refilling.

- ► Most portable generators are not meant to run continuously, so give your generator a break.
- ► For tractor-driven units, be sure to always turn off the tractor and PTO control to service the generator. Set the tractor brake before starting the generator.
- ► Avoid using generators in wet areas to avoid electrical shock.
- ▶ Only connect loads to the generator when it is fully running. Disconnect the loads before starting the generator and before stopping it. This protects your generator, as well as your appliances, from damage.
- Make sure to use heavy duty cords sized for your power needs to prevent fires or shock.
- ► Most importantly, NEVER connect the generator into your breaker panel or into your house outlet without a transfer switch.

The transfer switch isolates your generator from the electric service and distribution lines. This keeps workers and the public from getting shocked by the electrical output of your generator, and it prevents your generator from burning up or shorting out.

# **Director elections slated for Zones 1, 2 and 3**

DEMOCRACY will take center stage at Claverack's 2020 annual meeting, with director election results highlighting the agenda.

Board seats are up for election in Zones 1, 2 and 3 this year. The election of directors will be conducted via mailin ballots. Each member will receive a ballot listing the names of all candidates seeking seats on the co-op board.

Members can expect to receive the ballots in early August. The completed ballots should be returned in the addressed, stamped blue envelope included with the annual meeting notice. Claverack must receive members' completed ballots no later than Monday, Aug. 31.

The announcement of election results will take place during the business portion of the annual meeting.

In accordance with Claverack's bylaws, director elections take place on a rotating basis, with three zones up for election each year. Elected candidates serve three-year terms. Directors are responsible for establishing co-op policies and overseeing business operations.

Candidates who have filed petitions to run for board seats are: incumbent Danise C. Fairchild, Zone 1; incumbent Robert R. Faux, Zone 2; and incumbent Angela Joines, Zone 3. A profile of each candidate follows.

# Zone 1

Zone 1 serves members in Albany, Asylum, Herrick, Standing Stone, Stevens, Terry and Wyalusing townships in Bradford County.

# Claverack teams up with Tri-County, CoBank to support Food Bank

CLAVERACK Rural Electric Cooperative teamed up with Tri-County Rural Electric Cooperative and CoBank to provide \$20,000 to the Central Pennsylvania Food Bank to assist families in need of food during the COVID-19 pandemic.

A \$5,000 donation from each of the electric cooperatives, matched by a \$10,000 donation from CoBank, one of the cooperatives' lenders, will be used to purchase food to fill crisis response boxes the Food Bank is providing to its distribution partners across Northcentral Pennsylvania.

"We are so thankful to these three organizations for providing much-needed support to the Central Pennsylvania Food Bank," said Joe Arthur, executive director of the Central Pennsylvania Food Bank. "Since the beginning of the COVID-19 crisis, our team has distributed more than 120,000 crisis response boxes and millions of pounds of fresh produce, milk, eggs, frozen meats and more to our charitable food network, enough to provide more than 14 million meals. Support like this helps us provide the healthiest foods available to those in need in our communities."

In response to heightened demand for nutritional assistance due to COVID-19, the Central Pennsylvania Food Bank began packing crisis response boxes filled with non-perishable food to meet the needs of its charitable food network in the 27-county area it serves.

This network includes local food pantries, soup kitchens, churches and community organizations that provide nutritional assistance to the public. There are more than a dozen of these partners receiving crisis response boxes in the cooperatives' service territories across the state's Northern Tier.

"Electric cooperatives are committed to supporting our local communities," said Bobbi Kilmer, president & CEO of Claverack Rural Electric

The donation included \$5,000 from each electric cooperative, along with \$10,000 in matching funds from CoBank's Sharing Success program. CoBank is a cooperative bank that offers financial services to cooperatives, including Claverack, across rural America.

Cooperative. "With so many people out of work and experiencing financial hardships due to the coronavirus pandemic, we wanted to help ensure families in our region have food on their tables during this unprecedented time of need."

Claverack funded its portion of the Food Bank donation through the use of unclaimed capital credits refunds, which all electric cooperatives in Pennsylvania are permitted to retain and use in support of community and low-income energy assistance programs.

Jennifer Sands, communications and marketing manager for the Central Pennsylvania Food Bank, said the Food Bank distributed 44% more food during the month of April than it had in April 2019.

She said the Food Bank's demand for food continues to increase, and it is expected that crisis response boxes will be provided to central Pennsylvania food distributors through at least the end of September.

Sands also noted the Food Bank has seen an outpouring of support from businesses, industry, charitable organizations and individuals since the pandemic began.

"The community has stepped up big time to help us out," she said.

Sands said the primary need for the Food Bank at this point is financial donations to support its mission to provide nourishment to families throughout central Pennsylvania. The Food Bank is currently not accepting direct food donations from individuals or community organizations.

# **Even out your payments with Levelized Billing**

You can avoid large fluctuations in your electric bill from month to month by participating in Claverack's Levelized Billing plan.

The program allows you to level out your monthly payments throughout the year.

Levelized Billing is available to members with at least one year of electric use, provided they have fewer than two late payments in the prior 12 months.

This plan is particularly helpful to members with electric heating or central air conditioning systems, since their electric bills tend to increase significantly during the heating and cooling seasons. It's also convenient for those on fixed incomes.

# **Operation Round-Up**

Financial hardships created by the COVID-19 pandemic have caused many cooperative families to struggle to keep up with their energy bills.



You can help some of your neighbors in need by participating in Claverack's Operation Round-Up program.

This voluntary program allows you to assist members of the cooperative experiencing difficulties paying their electric bills. Participating in the program is inexpensive – less than \$1 a month – and allows you to help make a difference in a neighbor's life.

### **CONTRIBUTING IS EASY**

The concept is simple. Claverack rounds up your monthly electric bill to the next dollar amount. The difference between the round-up amount and your actual bill amount goes into our member assistance fund.

For example, if your electric bill is \$100.32, then you would pay \$101. The extra 68 cents goes into our member assistance fund for needy families of the cooperative. The average yearly donation is \$6.

# CAN YOU SPARE MORE THAN CHANGE?

If you'd like to help your fellow members even more during this unprecedented time of financial uncertainty, we have created additional options for you to contribute more than the traditional round-up amount.

Members can add an extra dollar amount to their monthly donation. Simply enter the even dollar amount that you would like to add to the Round-Up form that can be found on our website, claverack.com, or call our office and ask your member service representative to make the change for you. Your bill will reflect the total amount donated each month.

If you would prefer to make a one-time donation to Operation Round-Up, that option is also available. Enter the one-time amount in the associated field on our online Round-Up form, and we will add that to your account. With the next bill you receive, the amount of your donation will be added to the total amount due, and you will see it listed as "Roundup Amt."
